





The meeting was opened with a prayer by Imre Golden from the Central Church of Christ at 1:30 PM.

Imre told us his church has installed a new air-conditioning unit. His church is willing to help all those that request assistance.

John Murphy told us about all the services provided by Saint Vincent de Paul. The volume of calls from those needing help has increased and they asked the congregation for volunteers. Thirty-eight people stepped forward. A lot of what SVdP does involves home visitations. If all 38 feel that is not their calling, there are other activities they can be involved with. There was an increase in needs up-county with fixing roofs, flood damage and increases in rent. In March, SVdP gave out \$11,400 in assistance. They had 89 calls for help, made 16 house visits and gave out 50 references for assistance. St. Katharine served 38 people supper. John told us that they have been getting some financial assistance from the Amador Community Foundation.

James Burke from the Amador County Behavior Health Department passed out a survey that the Behavioral Health Department is giving that will help them better serve our community. He also reminded us of the Homeless Resource Fair on May 21st and May 22nd.

Julie Roberts from the Church of Jesus Christ of Latter Day Saints told about a truck of food being delivered from Salt Lake

City to the Interfaith Food Bank. She reminded us of the webpage JUST SERV

Steve Christensen talked about Project ReStart at Trinity Episcopal Church and the bins of supplies that the church has supplied to victims of natural disasters. Steve also told about the ten Homeless Assistance Resource Teams (HART) in Sacramento. Trinity Church is talking about forming a HART chapter in Amador County to help the unhoused. If Trinity goes forward with this ministry, you will be hearing more from me as Trinity will need multiple churches and community organizations to make this ministry a reality.


