- Any other matters not on the agenda.

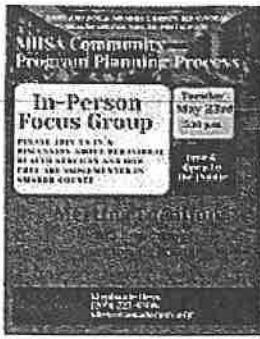
As always, the general meeting will be followed by the Family Support Group in person at 7 pm.

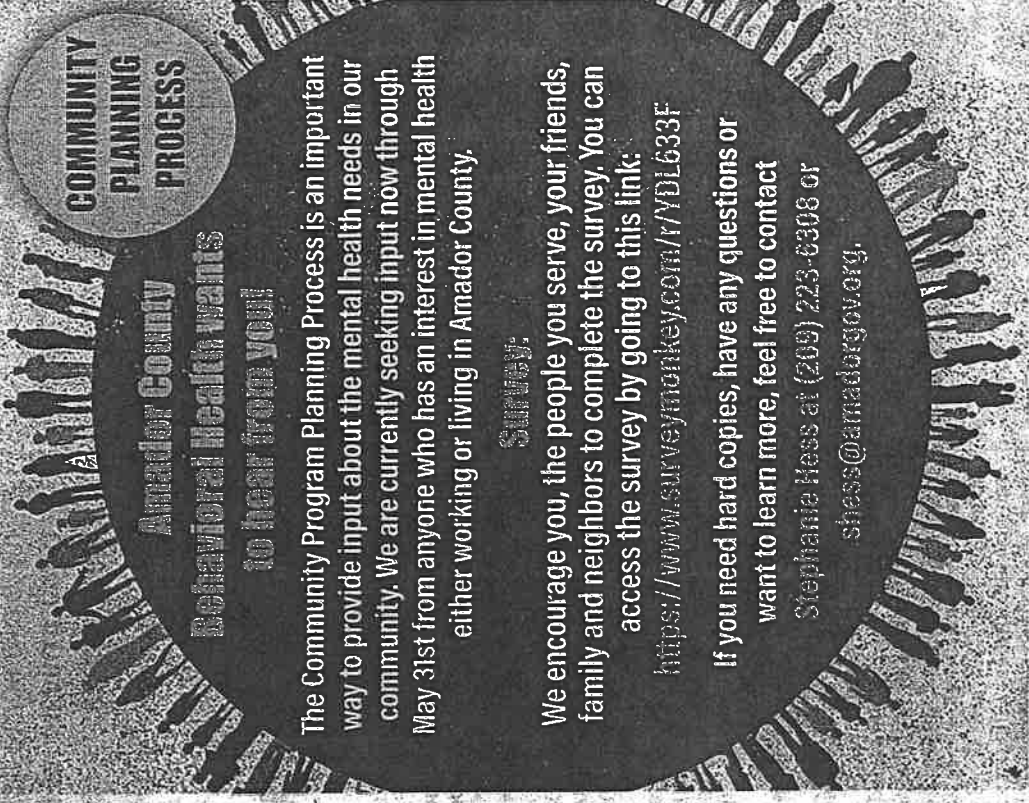

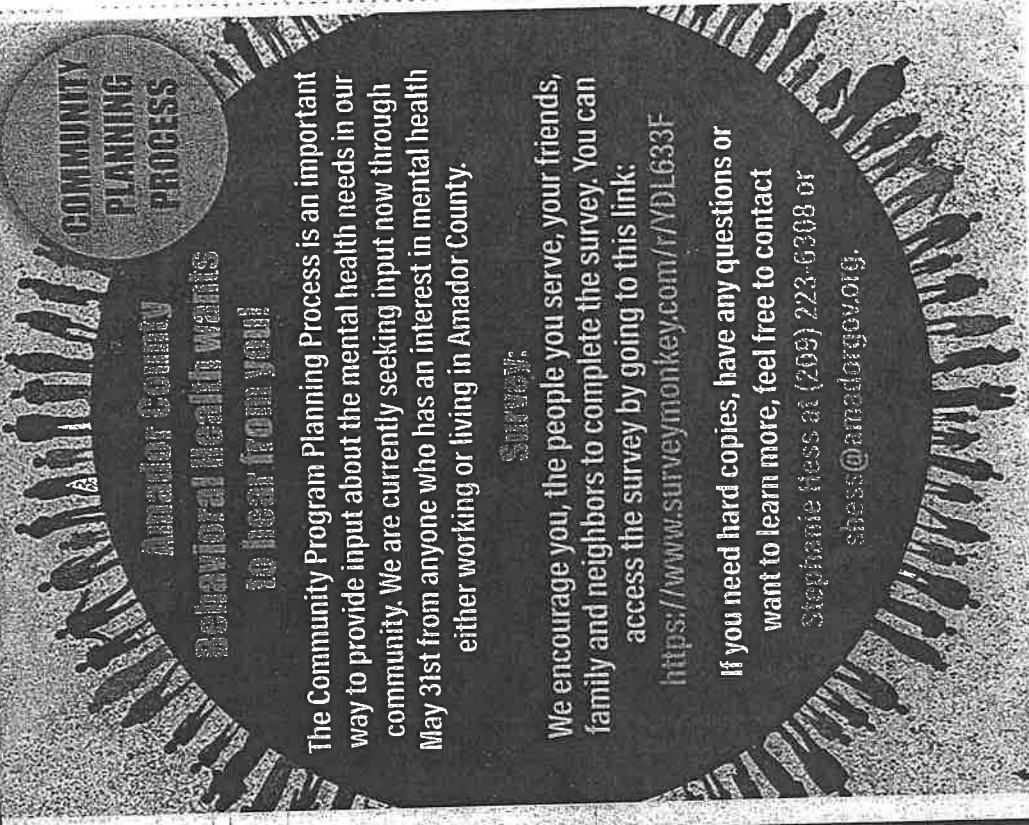
