Our Legal Services

Housing | Tenant's rights, wrongful evictions, subsidized housing, mobile home park issues, housing discrimination, homeowners facing foreclosure due to fraudulent schemes

Income Maintenance | Assistance with General Assistance, CalWORKs ("cash aid"), CalFresh ("food stamps"), Social Security (SSI, SSDI, Retirement), pensions

Health Care Benefits | Medi-Cal, Medicare, Denti-Cal, CMSP, Covered CA

Employment Law | Unemployment and state disability claims, unlawfully denied benefits or wages

Education | Special education plans, access to education, expulsion, disciplinary hearings

Senior Issues | Safety, economic security, health, housing and consumer issues for individuals aged 60 and over

Pro Per Assistance | Limited assistance to Pro Per (unrepresented) litigants in civil cases in Placer, El Dorado, Amador, Nevada and Sierra counties. Eligible clients will not receive individual representation, but will be assisted in the preparation of their own cases.

We do not handle criminal cases, traffic tickets, trusts/probate issues, personal injury cases, or most family law cases.

Eligibility Requirements

To receive services, our funders require that you:

1. Reside in Placer, Nevada, Sierra, El Dorado, Amador or Calaveras counties.
2. Meet income-eligibility guidelines (seniors living in Placer county do not need to meet income-eligibility guidelines),
3. Have a problem that fits within the services we offer.
